These are the things that we, the sixteen students remaining in President Hanlon's office as of 3pm Thursday the 3rd of April 2014, need in order to leave this office today.

We need to be assured that there will be no punishment ~~of any sort~~ ^{beyond agw} for anyone who participated in this sit-in at any point. ~~This includes but is not limited to no judicial review,~~ ^{agw} no COS process, no financial aid or scholarship revocation, no impact on any 5th or 6th year of study, no impediment of graduation, no FSP/LSA revocation, or any other impediments of our educational or social experiences. ~~However, if a student is brought up on judicial charges again, this particular violation can be taken into account in determining the level of sanction.~~

We need to be assured that after this protest, the College will provide adequate protection from threats and violence from our fellow students and anyone else who threatens us. We need to be able to call S&S and SafeRide whenever we need, and SafeRide needs to be willing to take more than one of us at once.


When the College or its representatives discuss the sit-in, especially when publicly, the College must stop referring to the students who have taken a stand merely in order to protect themselves and their wellbeing on this campus as "threatening" or similar terms. We are not a threat, though we may have been an inconvenience; it is our safety and wellbeing that are daily threatened on this campus.

We need the assurance of an independently conducted external review survey of Dartmouth campus climate with full-disclosure ~~(the raw information will be reported by the 3rd party reviewer is made public by the College to be completed by the end of 2016.~~

(Full disclosure meaning that whatever is released by the 3rd party reviewer will be directly released to the public) completed by the end of 2016.

We need to receive from the Administration, President Hanlon, and Dean Johnson by Monday the 7th of April 2014, a list of which decision-makers would be responsible for or have jurisdiction over each budget item. We need the aforementioned individuals to divide these decision-makers into groups based on their areas of responsibility as it relates to Freedom Budget items; these groups would facilitate efficient and constructive conversation around action items in their respective areas. In support of us students, we need these meetings to be open to all members of the Action Collective, President Hanlon present, and livestreaming available. We need the Administration to have organized for us, and for us to have held these meetings, by Friday the 2nd of May 2014.

Dean Charlotte Johnson's signature here represents the force of the College, as President Hanlon is not in attendance.


