Summary of Significant Changes to the NIH GPS for October 2013 Version

(Guide Notices Issued Before October 1, 2013)

The revised NIH Grants Policy Statement (NIHGPS, rev. 10/01/2013) represents an update to the 10/01/2012 version and is applicable to all NIH grants and cooperative agreements beginning on or after October 2013. While the update does not introduce any new material for the first time, it incorporates new and modified requirements, clarifies certain policies, and implements changes in statutes, regulations, and policies that have been implemented through appropriate legal and/or policy processes since the previous version of the NIHGPS dated 10/01/2012. The 10/01/2013 revision supersedes, in its entirety, the NIH Grants Policy Statement (10/01/2012) as a standard term and condition of the award.

Notable Policy Changes: Implements new policies and clarification of existing policies announced in the NIH Guide since October 2012, and listed at Grants Policy & Guidance.
