PROGRAM OVERVIEW

TRADITIONAL MEDICAL SCRIBE ROLE

A traditional medical scribe (also referred to as a medical transcriptionist, a hospital scribe, etc.) accompanies the provider into the patient exam room to assist with recording the patient's history in the Electronic Medical Records (EMR) system. Other duties include transcribing proper diagnoses into the patient's chart and recording procedures, results, evaluations and discharge/follow up instructions, as directed by the provider.

OSH APPROACH TO PRIMARY CARE & THE CIS PROGRAM

Oak Street Health is an innovative network of primary care clinics focused on providing excellent care for older adults. We practice team-based, preventive medicine with a focus on population health, and we use high-powered analytics to guide our care. We are quality-focused, meaning we judge our success on the value of our patient experience and the health outcomes of our patients. In 2014, we developed the Clinical Informatics Specialist program precisely to improve these elements of our practice. What other practices call "scribes," we call Clinical Informatics Specialists ("CISs"). CISs are vital to their care team through their expertise in:

- EMR workflows
- Real-time diagnostic coding and billing
- Population health dashboards

We extend offers to individuals who seek challenges. An ideal candidate is energetic, clever, and detail-oriented with a strong interest in gaining clinical experience prior to health professional school. Our team is comprised of applicants who proved themselves academically in their respective undergraduate institutions or post-baccalaureate programs and have compelling relevant experiences.

Other accepted applicants pursue careers in areas of health care such as data analysis, health administration, or social work. After 1-2 years of experience at Oak Street Health, CISs are greatly prepared to continue advancing professionally.

CIS TRAINING PROCESS

CISs go through two weeks of rigorous, standardized training, including over 80 hours of classroom and scenario based training, shadowing, and 1:1 coaching in-clinic. They then receive frequent ongoing training, including 1:1 coaching, monthly regional training, and quarterly company-wide CIS education sessions. Furthermore, we have Certified Professional Coders (CPCs) work with our CIS program to ensure we are billing and coding at today's standards.
